WHAT IS THIS PRODUCT?

Type: Balance crafted by Ruth is a sub-fund of Ruth Asset Management SICAV, a public limited company incorporated as an investment company with variable share capital and subject to part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment.

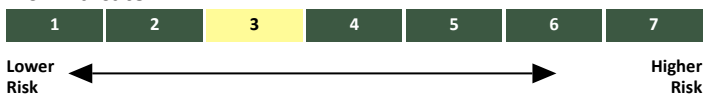
Term: The sub-fund has no maturity date. However, please note that the sub-fund may be closed if it is in the interest of the shareholders and endorsed by the board of the fund in accordance with specific conditions or circumstances as described in the fund prospectus.

Objective: Balance crafted by Ruth's objective is to outperform its benchmark index over the long term. Balance crafted by Ruth's benchmark index is a composite index consisting of Swedish and global equity indices, as well as a Swedish and a global bond index (35% Bloomberg Barclays Global Aggregate Index Total Return (currency hedged to SEK), 45% MSCI ACWI Index Total Return Net (50% currency hedged to SEK), 10% Solactive SEK IG Credit, and 10% SIX Portfolio Return Index (Total Return)). Balance crafted by Ruth is an actively managed sub-fund whose assets are invested without geographical limitations in the equity and bond markets, as well as in alternative investments. The sub-fund may have high exposure to certain regions and countries. The sub-fund invests in debt instruments issued by companies, governments, and other issuers. The risk is calculated as Value at Risk and is expected to range between 0.4 – 1.2 times the Value at Risk of the reference portfolio. The sub-fund promotes environmental and/or social characteristics as well as good governance and is categorized as Article 8 in accordance with the EU Disclosure Regulation (SFDR). The sub-fund follows the management company's sustainability guidelines, which are available at www.ruthassetmanagement.com.

Intended Retail Investor: This fund may be suitable for investors who plan to hold their investment for at least 3 years and who understand that the money invested in the fund may both increase and decrease in value and that it is not certain that the entire capital invested can be returned. Investing in the Fund does not require any specific prior knowledge or experience of UCITS or financial markets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The risk indicator assumes that you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The product has no end date.

Risks not captured by the risk indicator:

Counterparty risk – arises if a counterparty does not fulfill its obligations towards the sub-fund, for example by not paying a set amount or not delivering securities as agreed.

Operational risk – the risk of loss due to, for example, system failure, errors caused by human factors or external events.

The summary risk indicator provides guidance on the level of risk of this product compared to other products. It shows how likely it is that the product will decrease in value due to market developments.

We have classified the product as **3 av 7**, indicating on a medium-low level.

This product does not contain any protection against future market performance. You may lose all or part of it.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Performance scenarios

The figures include all the costs of the product itself but may not include all the costs you pay to your adviser or distributor. The figures do not consider your personal tax situation, which can also affect how much you get back. What you get from this product depends on future market performance. Future market developments are uncertain and cannot be predicted precisely. The unfavourable, moderate, and favourable scenarios show the worst, average and best performance of the product over the past 10 years. The stress scenario shows what you might get back in extreme market circumstances. The scenarios occurred for an investment between 2015-2025. Markets could develop very differently in the future.

Past performance is not an exact indicator of future performance. It can help you to assess how the sub-fund has been managed in the past. What you get will vary depending on how the market develops and how long you keep the product.

WHAT HAPPENS IF RUTH ASSET MANAGEMENT SICAV IS UNABLE TO PAY OUT?

Each fund must have a dedicated depository to take care of the safekeeping of the sub-fund's assets. There is a potential default risk if the assets of the sub-fund held with the depository are lost. However, such default risk is limited due to the segregation of assets between those of the depository and the sub-fund. The depository is liable to the sub-fund or to the investors of the sub-fund for the loss by the depository or one of its delegates of a financial instrument held in custody unless the depository can prove that the loss has arisen as a result of an external event beyond its reasonable control. For all other losses, the depository is liable in case of its negligent or intention failure to properly fulfil its obligations pursuant to the Luxembourg law of 17 December 2010 relating to undertakings for collective investment. There is no other compensation or guarantee scheme for investors in the sub-fund.

WHAT ARE THE COSTS?

The person advising you on or selling the product may charge additional fees. If that is the case, they must inform you about these costs and how they affect your investment. If the sub-fund is included as part of another product, for example an investment insurance, other fees may apply for that product.

Costs over time The tables show the amounts taken from your investment to cover various types of costs. The amounts depend on how much you invest, how long you hold the product, and how the product performs. The amounts shown here are based on an example investment amount and various possible investment periods.

We have assumed the following:

- In the first year, you get back the amount you invested (0% annual return). For year 3, we have assumed that the product performs as shown in the neutral scenario.
- 100,000 SEK is invested.

* This illustrates how costs reduce your return each year during the holding period. This shows, for example, that if you redeem at the recommended holding time, your average return per year is estimated to be 12,1% before costs and 10,2% after costs. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?**Recommended holding period: 3 years**

The sub-fund has no minimum holding period requirement and is suitable for a medium-term investment horizon. You should be prepared to hold the sub-fund for at least 3 years. You can generally sell your fund shares on any business day without any additional fee.
